### **APPROVAL OF MINUTES**

1. \*Parks and Recreation Meeting Minutes of September 20, 2021.

Without objection this measure was read by title and approved under the consent agenda.

# **REPORTS**

1. Director's Report by Donnie Hayes, Parks and Recreation.

Donnie Hayes, Parks and Recreation Director, informed the Commission of the Halloween Trick or Treat Town fundraising event at Pioneer Park, proceeds will go to Access Alaska and the Pioneer Park playground. Mr. Hayes also mentioned the winter lights walk and the go winter expo at the Carlson Center. Mr. Hayes provided status updates on restoration projects at Pioneer Park, including, the Pioneer Park Church, which is over one hundred years old, and the train trestles. Further status updates included Blue Bell Park, Chena Lake ice huts, Parks and Recreation staffing issues, reduced hours and vacant positions.

The Commission questioned and discussed with Mr. Hayes the following:

- Where to purchase tickets for Halloween Town.
- Carlson Center events calendar.
- Vacancies and staffing changes.

2. FNSB Comprehensive Recreational Trails Plan Update by Bryant Wright, Parks and Recreation Trails Coordinator.

Bryant Wright, Parks and Recreation, Trails Coordinator, provided a presentation on the FNSB Comprehensive Recreational Trails Plan Update. Mr. Wright explained the context and history of the trails and the trails plan, the borough's role and the reasons for the update. Mr. Wright explained the overall process of updating the plan, current progress and the goals and vision.

The Commission questioned and discussed with Mr. Wright the following:

- Comparability of motorized trails and non-motorized trails.
- Nature interpretation of the trails on a guided hike.
- Public comment on personal safety on trails.
- Resources to enforce rules or regulations to protect the use designation of the trails; preventing ATV use on trails where the use is not allowed; the FNSB does not have a ranger or police authority to enforce rules or regulations.
- Trail maintenance.
- Realignment of trails on private property.
- Whether the FNSB has eminent domain of trails; FNSB does not exercise eminent domain for trails in the trail plan.
- Future trail corridor identification public meetings on October 25<sup>th</sup> and November 22<sup>nd</sup>, 2021.
- ATV's on public roads.
- The location of the division of east and west trails; generally, the Steese Highway is where the divide is located.
- Whether the Trails Advisory Commission intends to address e-bike questions, comments or policies.
- Classification of e-bikes.
- Collaboration efforts with school trails and the University of Fairbanks trails.
- Care of schools and university trails, partnership and coordination of the care of the trails.

Further discussion ensued on the future trail corridor identification public meetings, identification of trails on maps and web address to locate additional information at fairbankstrailsplan.com.

#### **NEW BUSINESS**

1. Review and Discussion of FNSB Code 4.04.070 Vacancies.

The Commission reviewed and discussed FNSB Code 4.04.070 with a focus on meeting attendance and quorum. The Commission also discussed expiring commission seats and commission vacancies.

October 28th Assembly meeting about the CIP projects, and he thanked the commission

for their letter of support for their many projects.
