GENERAL REQUIREMENTS:

1. This license is issued pursuant to the authority contained in Section 20.16.040 of the Fairbanks North Star Borough Code of Ordinances. This
2. This license is **revocable** immediately by the Borough, with or without cause. The Borough reserves the right to inspect the premises at any time.
3. The materials to be removed are to be used by the licensee for their own **personal use only** and none of these materials are to be bartered or sold. Removal of materials may begin only upon receipt of a valid and approved copy of this license.
4. The licensee must have this license in their possession while obtaining and transporting the material authorized by this licensee. This license is non-transferable.
5. **STUMPS WILL BE LEFT NO MORE THAN 12 INCHES HIGH.** Anything cut 5 inches or larger in diameter will be removed by the licensee. The cutting area shall be left in an orderly condition conducive to the operations of others in the cutting area.
6. Use of **heavy equipment is prohibited:** including but not limited to skidders, log trucks, dozers, loaders or excavators.
7. When firewood cutting areas are delineated with flagging and signs, do not cut outside of the flagged area. Do not leave trees partially cut.
8. The licensee shall defend, hold harmless and indemnify the Borough, its officers, agents and employees, against any claims, loss, and/or damage directly or indirectly arising from or claiming to arise from any injury to any person(s), damage to property, or any economic loss. This obligation shall be continuing in nature and extend beyond the term of this agreement. The doctrine of equitable tolling extends the time within which an action for breach of this provision may be filed. "Licensee" and "Borough" as used in this section, include the employees, agents, sub-contractors, and any other persons who are directly employed by or otherwise legally responsible, respectively to each party.
9. **DO NOT BLOCK THE ROAD. Licensee will keep all roads and trails clear of trees, brush, vehicles and personal property. Licensee shall remove all brush, branches, and debris from roads, trails, drainage ditches and open areas adjacent to roads and trails prior to leaving the cutting area.**
10. This license is non-exclusive. Please be mindful that you may encounter other people who may be in the area.
