



## Fairbanks North Star Borough Regular Municipal Election October 5, 2021

Elections for Borough Mayor, Assembly, School Board and IGU are conducted at large by all qualified voters of the borough. All seats represent the whole Borough.

### BOROUGH MAYOR, ASSEMBLY AND INTERIOR ALASKA NATURAL GAS UTILITY BOARD (IGU)

#### Borough Mayor

3-year term

Incumbent: Bryce J. Ward

#### Borough Assembly

Seat A – 3-year term  
Incumbent: Marna Sanford

Seat F – 3-year term  
Incumbent: Liz Lyke

Seat G – 3-year term  
Incumbent: Leah Berman Williams

#### Interior Alaska Natural Gas Utility Board (IGU)

At-Large Seat A – 3-year term  
Incumbent: Pamela Throop has termed out

At-Large Seat B – 3-year term  
Incumbent: Mary Nordale

#### Qualifications. Candidates must:

- Be a qualified voter of the state of Alaska at a residence within the Borough.
- Have resided within the Borough for a period of one year preceding filing for office.
- A person shall not occupy or be a candidate for more than one elective seat at a time.
- Meet requirements as set forth in FNSBC Title 5.

Terms. The term of office is three years or until a successor is elected and qualified. Service is to begin on the first Monday following certification of the election.

A person who has served two full successive terms may not be reelected to that elective office or body until one full year has intervened.

### SCHOOL BOARD

Seat A – 3-year term  
Incumbent: Erin Morotti

Seat B – 3-year term  
Incumbent: Chrya C. Sanderson

#### Qualifications. Candidates must:

- Be a qualified voter of the state of Alaska, and a municipal voter (30 days before the election) in the school district.
- A person shall not occupy or be a candidate for more than one elective seat at a time.
- Meet requirements as set forth in FNSBC Title 5.

Terms. The term of the office is three years and until a successor takes office as set forth in AS. 14.12.050.

### REQUIRED WHEN FILING FOR ELECTED OFFICE

- Completed Declaration of Candidacy under oath.
- Completed Public Office Financial Disclosure statement that complies with state law (AS 39.50)  
Filers must file their POFD forms electronically via MyAlaska (<https://myalaska.state.ak.us/apoc/form/>), then print a copy to file with the clerk. For more information contact APOC at [apoc@alaska.gov](mailto:apoc@alaska.gov) or 800-478-4176
- \$25 non-refundable Filing Fee
- A Municipal Exemption Statement or Candidate Registration within 7 days of filing for candidacy
